



POOCHIES PARK DOG RUN/JOG/WALK REQUIREMENTS

You must agree to these Requirements and Waiver of liability. Please read it now so that you'll be able to sign it on the morning of our event when you check in at the Registration Table.

1. All dog walkers must be over the age of 18 or accompanied by an adult over 18.
2. Dogs must have all vaccinations current as required for the dog park. Rabies, Distemper, Hepatitis, Parvo, Parainfluenza (DHPP). We normally require Leptospirosis (L) and Bordetella vaccine but will be waiving it for this event day.
3. All dogs must be always kept on a maximum 6-foot leash (retractable leashes are dangerous when people/dogs are around. They must be in the locked mode).
4. Only 2 dogs per handler.
5. Participants **MUST NOT** allow their dog to step off the road and onto the neighbors' front yard. **DO NOT ALLOW YOUR DOG** to stop to pee or poo or walk on private property. Stay on the road. Participants must come prepared to clean up after your dog just in case.
6. Female dogs in heat cannot be allowed to participate.
7. At the sole discretion of the Organizers, dogs whose behavior is unruly or might prove to be hazardous to other Participants, dogs, or spectators, will be requested to leave the Dog Run/Jog/Walk event.

Release, Waiver and Confirmation

- a) You understand and agree that you and your guest(s), are solely responsible for any damages to other people, dogs, or property caused by your dog no matter what the circumstances are. You are legally and financially responsible for those damages caused by your dog, yourself, or your guests.
- b) Poochies Park ("Organizer") is committed to conducting its Event and related activities in a safe manner and holds the safety of participants and their dogs in high regard. The Organizer continually strives to reduce such risks and insists that all Participants follow safety rules and instructions that are designed to protect the Participants' and their dog(s) safety. However, Participants and parents/guardians of minors registering for the Event, must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs. You and your guest(s), understand the risks of this type of outdoor activities including, but not limited to, mud, puddles, potholes, traffic, slips, falls, weather, etc.
- c) Participants hereby grant the Organizer, specific permission to reproduce, publish, circulate, copyright, or otherwise use all photographs and/or videotape of me, family guests, taken at the event, for use by the Organizer.
- d) You represent that your and your guests' dog(s), are in good health, are current on all required vaccinations and have not harmed, shown aggressions, or exhibited any threatening behavior towards any person or other dog. You confirm your, and your guests' dog(s) do not have any condition that could potentially jeopardize the health of other dogs or people and has not had any potentially communicable condition within 14 days prior to the event.

- e) Participants are expected to always exhibit responsible pet ownership, appropriate behavior, and obeying all laws. This includes respect for all people, equipment, and facilities, and cooperative, positive participation. The Organizer reserves the right to dismiss anyone whose behavior endangers safety or negatively endangers safety or negatively affects the event, a person, a pet, a facility, or property of any type or kind.
- f) Participants also agree to indemnify the Organizer, its employees, or volunteers, from all injuries, damages to person or property caused in whole or in part by the Participant's actions or the actions of their dog(s).
- g) You and your guests further understand and agree that neither Organizer nor any of its employees or volunteers, will be liable for any personal items and/or property that is lost/stolen or damage. That neither Organizer nor any of its employees, staff, or volunteers, will be liable for illness, injury, death and/or escape of your dog(s) provided that reasonable care and precautions are followed, and you hereby release all of them of any liability of any kind whatsoever arising from or as a result of your or your or your guests' dog(s) participation in the Event.

You, and your guest(s) have read this Agreement and understand the contents. You sign this Agreement voluntarily (and by signing you also assume all liability for your guests and sign on their behalf that they have read this waiver and agree to it). You understand that this waiver means the assumption of all hazards and risk, giving up the right to bring any claims including for personal, guests and participating dogs injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim to seek damages, whether known or unknown, foreseen, or unforeseen.
